# FLEXIBLE PROGRAM OPTIONS TO FIT YOUR LIFE

We offer a 90-credit-hour Juris Doctor (J.D.) program with three flexible scheduling options so you can choose the option that best suits your lifestyle.

## **Full-time Schedule**

A full load of on-campus classes over the course of three years.

## **Flexible Schedule**

A reduced load of on-campus, daytime classes over the course of four years.

## **Executive Schedule**

A reduced load of blended and online classes over the course of four years. Blended classes will meet on campus every other weekend during Friday evenings and Saturdays and will have an online education component during the week. Students also take online classes during the summer.

No matter what scheduling option you choose, our rigorous academic program emphasizes both a deep understanding of the law and legal analysis and the accumulation of a broad range of skills necessary to practice law successfully.
